

## Offer for new clients of AS Citadele banka Eesti filiaal in cooperation with Barbora

## Who can use the Citadele Barbora offer:

- 1. The offer can be used by new clients of the Bank, if the Participant is a former client of the Bank, the offer also applies to him provided that the client's last account with the Bank was closed no less than six months before the start of the promotion period.
